

# South Dakota Smallbore Rifle Prone State Championship

AUGUST 15, 2010 Utica, South Dakota

Location: Yankton County Sharpshooters Range, 2 1/2 miles south of Utica, South Dakota.

**Authorization:** Registered with NRA, approved by SDSSA and sponsored by Yankton Co. Sharpshooters Rifle and Pistol Club.

**Eligibility:** Competitors must be NRA and SDSSA members. Nonresident competitors must be members of their state NRA affiliated association in lieu of a SDSSA membership. Junior competitors are required to be member of a NRA affiliated club only, NRA and state association membership is not required of juniors.

**Classification:** All competitors will be classified for award purposes according to NRA Classification. NRA Classification Cards required.

**Rules:** Current NRA Smallbore Rifle Rules will govern. Rifle Rule: 3.2.

**Registration and Entry Fees:** Reg. Fee- \$5.00 entitles each competitor to a copy of the final bulletin.

**Match entry fees:** Matches 1-9; Adults \$2.50, juniors \$1.00.

**Total entry fees:** Matches 1-9 plus registration fee: Adults \$27.50 Juniors \$14.00

**Entries:** Advance entries requested. Mail notice of intent to; George J. Cwach, 4301 West City Limits Road, Yankton SD 57078. Post

entries accepted to 9:30 AM on day of the tournament to range capacity of 20 competitors. Stat. office open at 9:00 AM. First relay to be called at 10:00 AM.

**Match Schedule:** All firing shall be from the prone position. Matches 1 and 4-5: 50 YARDS. Matches 2 100 yards #1-40 shots. Any Sights, A-27 Target, 20 shots per tgt, 20 minutes per tgt.

#2- 40 shots. Any Sights, A-25 Target,

#3- Any Sight Aggregate- Matches 1 -3

#4- 40 shots. Metallic sights, A-23/5 Target, 20 shots per tgt, 20 minutes per tgt.

#5- 40 shots. DEWAR Metallic sights, 20 shots 50 yards A-23/5, 20 shots 100 yards A-25 Target,

#6- Metallic Sight Aggregate- Matches 4-5

#7- South Dakota Individual Champion — Aggregate of matches 1-2 & 4-5.

**Range Operation:** Competitors will be squaded in two relays. They will be expected to mark their own targets and assist each other

in mounting and retrieving targets. Scoring will be done in the state office and the scored targets will be displayed.

**Challenges:** Rule 16.1, Fee \$2.00. Time limit: 30 minutes after last targets of match 7 are scored and displayed.

**Awards:** Seventy percent of entry fees will be returned. Matches 1-8: Match winner and 2nd in each class if 4 or more in class;

Match 9: SD Prone Champion, SD JR Prone Champion (if two or more Juniors compete), SD Senior Prone Champion.

In matches 1 through 8 adult competitors will be awarded cash or award points. Juniors NRA Medals. Match 9: SD Individual

Champion Trophy by SDSSA, SD Junior Champion Trophy by YCSS, SD Senior Champion Trophy by YCSS, The SD Individual

Trophies are limited to SD residents, if a nonresident individual is high overall, a suitable award will be provided. The sponsors

reserve the right to combine classes for award purposes if an insufficient number enter a class.

**Additional information:** The range has a covered concrete firing line. Ear protection is recommended. Competitors need to provide their own refreshments.
