**Match Date/Times : 4 Position Match Portion Saturday, April 2nd 2011**

**3 Position Match Portion Sunday, April 3rd, 2011**

Registration opens at 8:00 AM 1st relay starts at 9:00 AM 2nd Relay starts at 11:00 AM 3rd really starts at 1:00pm

**Sponsors and Authorization :** Sponsored by the Dakota Sharpshooters  
Authorized by South Dakota Shooting Sports and the National Rifle Association.

**Location :** Davison County Pistol & Rifle Club

**Eligibility:** Competitor's must be members of the South Dakota Shooting Sports Association (memberships available the day of the match), or members of an SDSSA Affiliated Club. NRA Membership is not required but is encouraged.

**Fees:** \$15.00 per event (3 Position or 4 Position )

**Rules & Equipment** Current NRA Smallbore Rifle Rules will govern. Any 22 rimfire rifle, 22 short, 22 long or Long Rifle Cartridge may be used. No 22 Magnums. (NRA SB Rifle Rule 3.1 & 3.2 ) Competitors may use any type of sights. (NRA SB Rifle Rule 3.7). All other Smallbore NRA Rules apply. All shooters must use an empty chamber indicator, hearing and eye protection. Competitors will mark, mount and retrieve their targets. Scoring will be done by the Stat Officer.

**Individual 4 Position Championship.** Aggregate of Matches 1 thru 3

**4 Man Team Championship** - Scores from Matches 1 thru 3 of each team member will be team score

**2 Man Team Championship** - Scores from Matches 1 thru 3 each team member will be Team score

**Awards:** The State Junior Championship for the 4P and 3P is being done in 2 locations, Eastern Division (Mitchell, SD) and Western Division (Lead, SD). Upon compilation of both divisional matches and the compilation of all scores, a State Junior Champion will be named.

**The State Junior Champion must compete in both the 3 Position and 4 Position Matches.** The Junior with the highest combined 3P and 4P score will receive a plaque from the South Dakota Shooting Sports Association. The State Champion must be a Resident of the South Dakota. If there is a Non-Resident winner a suitable award will be provided by the Sponsor.
